I. CALL TO ORDER

a) Sub-District 7 has looked into the feasibility of purchasing land which would be a good site for a water retention area. The R.M. of Hanover is interested in partnering in such a purchase. The Board consensus is that the SRRCD continue to actively pursue this prospect;

b) The City of Steinbach has recently completed a study for a \$3 million project for water retention / flood protection. A copy of the study is provided to the SRRCD;

c) Reminds the Board that the sub-districts need to ensure that all projects are re-affirmed under CD policies versus municipal responsibilities before they are recommended at the Board level.

IX. NEW BUSINESS

a) Participation in CEC hearing for the Pembina Valley Water Co-op proposal. SRRCD participation in a proposed Clean Environment Commission hearing is discussed. The consensus is that there is a lack of data and that SRRCD involvement would be beneficial to the municipalities who have concerns regarding the Pembina Valley Water Cooperative Supplemental Groundwater Supply System project. Funding is available to cover costs of hiring consultants to gather the necessary data regarding this project. The Manager is to keep the Chairman updated on this matter.
